

IVYBANK AUXILIARY HOSPITAL, NAIRN

Ivybank Auxiliary Hospital was established at Ivybank House Nairn in November 1914 and was staffed by members of the Nairnshire Voluntary Aid Detachment which had been established in 1911. The register for the hospital contains several pictures of patients and nurses. There are weekly references in the “Nairnshire Telegraph” to food and gifts being donated for the hospital.

The patients came from the general military hospitals at Aberdeen and Inverness to recuperate at Nairn and the hospital was only for “other ranks” and not officers. The register only runs up until December 1916, although the hospital continued to exist until 1918.
